**RE: Amendment #6 to the 2007 – 2012 Forest Stewardship Plan, TFL 58, FL A16870, TL T0184, TL T0253**

Dear Len Munt:

Pursuant to FRPA Sec. 20(2), this letter provides notification that Teal Cedar Products Ltd. (Teal) has prepared an amendment to the above referenced forest stewardship plan.

Per FPPR Sec. 30(2), this amendment takes effect on the date it is provided to the district manager (July 8, 2009).

This amendment does not require approval per FRPA Sec. 20(1)(a), and does not conform to the described circumstances requiring approval as specified in FPPR Sec. 29(b).

## Amendment

The boundary of Forest Development Unit (FDU) 'C' is modified to add 0.4 ha in the vicinity of proposed Cutblock EAST04, 22.2 ha in the vicinity of proposed Cutblock

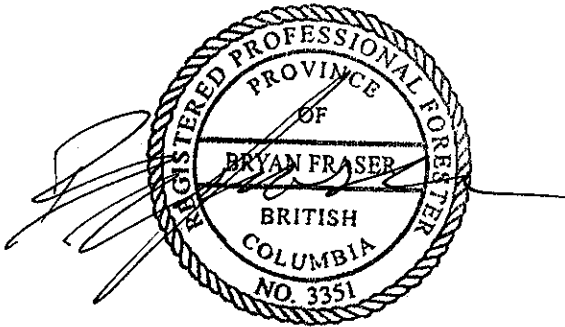
EAST08 and 0.9 ha in the vicinity of proposed Cutblock EAST12. These additions are shown on the attached amended map.

Rationale

In 2003, TL T0207 expired and the area formerly under the timber licence reverted to TSA 25 which is within the operating area of FL A16870, held by Teal. Due to a mapping oversight, the footprint of expired TL T0207 was inadvertently excluded from FDU 'C' when the 2007 FSP was prepared. Nine cutblocks within expired TL T0207, including EAST04, EAST08 and EAST12, were deemed to be FSP approved under FRPA Sec. 196(2), but were not mapped within FDU 'C'. The areas added to FDU 'C' in this amendment are made to include them in the FDU. I have determined that the proposed amendment does not materially change existing FDU 'C.'
